Input from Fresh Water Fisheries Society and others for final format

Some may dispute the wording and results of some questions but we have tried to eliminate perception of bias.

We believe the sample size is sufficient to be an indicator of angler concerns and preference

We believe the information gathered can be useful in ongoing and future discussions relating to fresh water fisheries

Considering the difficulty in getting the committees functioning in all regions we believe the information received from all regions can be valuable to the PAAT members as it is indicative of grass roots concerns.

For example resident participation in the steelhead fishery has spiraled downward with the implementation of bait bans and non-retention of wild steelhead. we've seen resident steelhead anglers diminish by about 8,000 over the past dozen years whilst at the same time non-resident participation increase by about a 1,000 anglers. There's a need for Monroe to be able to restrict non-residents independent of residents to reflect resident priority to our fishery. For example if a bait ban or non-retention is implemented why are residents impacted in the same manner as non-residents. It should be the non-residents that are restrict first and foremost before that of resident anglers that call BC home.
